meeting of executive committee held on 09.12.2008 at Exh.18, Appointment letter of Election Officer at Exh.19, consent letter given by Election Officer at Exh.20, notice of meeting of general body held on 09.01.2009 at Exh. 21, minutes of meeting of general body held on 25.01.2009 at Exh. 22, list of members at Exh.23, certified copy of Inq.No.643/2004 along with memorandum of association and rules and regulations of the trust at Exh.24, acknowledgement receipts at Exh.25 to 27, 33 & 34, report submitted by Peon of Shri Shivaji Mahavidyalay, Akot Tq.Akot Dist.Akola in respect of information regarding general body meeting dt.15.1.2009 given by him to the mother of trustee namely Ku. Ekta Dinkarrao Mahajan at Exh.37. There is delay of 10 years 05 Months 06 Days in reporting the present change to this Authority and same be condoned today itself vide order dated 11.10.2019 below Exh.04.

- 3.- The Rules & Regulations of the trust goes to show that, the President of the trust is vested with power of issuance of notice of the general body meeting to the members. 
