- The BONDE PATHOLOGY LABORATORY, AKOT is also desirous to conduct a similar activity and would be involved in the same to the extent laid down in this MOU.
- The purpose of the activity is to provide the free Blood Group, Blood Sugar, Hemoglobin, Blood Pressure Check-Up facility for the students and staff of the college and also for the society.
- The outcome measures of the project shall be conducted through different pathological laboratory techniques, and the findings will be helpful for generating the awareness about health related practices, blood donation etc.

NOW IT IS AGREED BETWEEN THE PARTIES AS FOLLOWS

1. PURPOSE AND OBJECTIVE OF THE RESEARCH/ PROJECT

- 1.1. To examine the Blood Group, Blood Sugar, Hemoglobin, Blood Pressure of the students, staff of the college and other participant during the camp organized.
- 1.2. To do all things necessary to success the organized camp. To the extent necessary, and to collect and analyze the data for the expected outcome measures

2. ARRANGEMENT

- 2.1. It is agreed and understood that DEPARTMENT OF ZOOLOGY, SHRI SHIVAJI ARTS, COMMERCE AND SCIENCE COLLEGE, AKOT shall organized the Blood Group, Blood Sugar, Hemoglobin, Blood Pressure Check-Up camp. It is agreed and understood that BONDE PATHOLOGY LABORATORY, AKOT shall provide

3. REponsibilities

- 3.1. The DEPARTMENT OF ZOOLOGY, SHRI SHIVAJI ARTS, COMMERCE AND SCIENCE COLLEGE, AKOT will act as the organizer for the feasibility of the study and will control and manage the day to day activities necessary for study.
- 3.2. DEPARTMENT OF ZOOLOGY, SHRI SHIVAJI ARTS, COMMERCE AND SCIENCE COLLEGE, AKOT shall also recruit the participants for the study.
- 3.3. The persons responsible for recruiting will also be responsible for taking informed consent and for collecting blood samples for testing purposes for the study / Camp.
- 3.4. The BONDE PATHOLOGY LABORATORY, AKOT shall be responsible for co-ordination of the camps and conducting the laboratory experimental work in the project.
- 3.5. The pathologist responsible for the laboratory work shall also be responsible for the proper handling of the samples, clinical materials, etc.

4. CONFIDENTIALITY

- 4.1. The parties and the persons responsible and working on the camps shall keep confidential all information relating to the project that is confidential in nature, including the participants' details, test reports, etc. Confidentiality of participants shall be maintained in all publications of the study too.

- 4.2. No confidential information shall be revealed to any third person without the express written consent of the party or participant whose information is confidential in nature.
- 4.3. Use of confidential information for any purpose other than the said purpose of the project shall not be allowed, unless all parties agree and give written consent for the same.
- 4.4. No public announcement, press release, public statement, etc. shall be made about the study/ project till its final completion and without the consent of all parties involved in the project.
- 4.5. Parties shall conform to the guidelines for study, good clinical practice and medical ethics and shall not breach the same.

5. VALIDITY

- 5.1. The MoU remain valid for the period of Five years from the date of signed by the parties and is renewable on mutual consent for further period as agreed upon.

6. CONSIDERATION

- 6.1. There is no financial consideration to be paid by either of the parties to this MOU.

- 7.1. The MoU shall be reviewed at the end of the one year from the date of signing.
- 7.2. One PARTMENT OF ZOOLOGY, SHRI SHIVAJI ARTS, COMMERCE AND SCIENCE COLLEGE, AKOT can terminate the MoU after releasing the one month notice to BONDE PATHOLOGY LABORATORY, AKOT or vice-versa to fulfillment of commitments that agreed upon.

8. AMENDMENTS

8.1. The MoU constitutes the entire understanding between both the parties hereto, except as otherwise provided herein, no addition, amendments or modification of this MoU shall be effected unless it is mutually agreed and signed by both the parties.

9. ANY DISPUTES

9.1. Any dispute appears on this on the credentials of the camps, or any other aspect of the camp or as to the rights and responsibilities and obligations of the parties hereto, the same shall be referred to the witness of the MoU, as agreed upon by both parties, for resolving the dispute and the decision of the said arbitrator shall be final and binding on all parties.

REPORT
